# PROGRAM OVERVIEW

CSU's business degree in accounting prepares you to practice as a public, private, or governmental accountant, or work in business managerial positions that require an understanding of fundamental accounting concepts and principles.

## Program Admission Requirements

- Previous college credit from a Colorado community college
- Grades of B- or higher in:
  - » One semester of calculus (equivalent to MATH 141)
  - » One semester of microeconomics (equivalent to ECON 202 or AREC 202)
  - » ACT 210 and ACT 220 (equivalent to ACC 121 and ACC 122)
- Cumulative GPA of 3.0 or higher on a minimum of 15 graded, college-level credits
- High school graduation or equivalent

Get a head start by applying for financial aid now. Complete the FAFSA application using the Colorado State University school code: 001350.

## Where are classes held?

The curriculum includes a blend of courses offered in person at the Sturm Collaboration Campus at Castle Rock and online.

## How many credits do I need to earn?

You will need to earn an additional 60 credits to complete your bachelor's if you already hold an associate's degree. If you have not completed an associate's degree, but meet the program admission requirements, you will need to earn additional credits that ultimately add up to 120 total credits.

## How much is tuition?

Tuition for the program is \$381 per credit, plus a \$25 technology fee per semester.

## How long will it take to finish the program?

You can complete your degree in two years with full-time course load and fall semester start.

## How do I apply?

The application will open in late May 2019.
